**081/2020-21** Apologies for absence, Cllr P Barnes, Cllr J Bryson

**082/2020-21** It was determined to take item 89/2020/21 without the public and press present in accordance with Public Admissions to Meetings Act 1960.

**083/2020-21** There were no Declarations of members' interests.

**084/2020-21** Public participation

- (a) Derbyshire County Councillor J Coyle reported that he had no information regarding school closures, although he was aware of some issues at Tibshelf School. Regarding the burger van at the top of Carnfield Hill Derbyshire County Council's default position was to allow it unless a specific reason existed to oppose it. Cllr J Coyle is meeting with The Highways department next week to discuss the situation. Residents who live nearby have complained about the smell. Cllr J Coyle has supported the Post Mill Centre Covid-19 group with a grant.
- (b) District Councillor A Joesbury that Bolsover District Council had issued a license to the burger van at the top of Carnfield Hill. He also reported that the Highways department had stated that its location was not unsafe. Cllr A Joesbury is trying to persuade developers of the Townend farm development to use Shiners Way as access to the development.

**RESOLVED** (unanimous) to award a grant of £1,500 to the Post Mill Centre Covid-19 Group.

**088/2020-21** To consider the working group verbal reports.

**REPORTED** by the Christmas Lights and Events Working group to move the Christmas Tree Lights Switch-on to 6<sup>th</sup> December due to the Lockdown, whilst switching on the lamp post Christmas lights a week earlier as originally agreed. Cllr A Joesbury will speak to the owner of the adjacent land to the Christmas tree regarding the switch-on. The Sports Hall and Youth Club Working group met with Lee Hicken, a senior officer at Bolsover District Council who has examined the Post Mill Centre plans and is going to meet with the Parish Council to make a presentation of his ideas to seek agreement and a way forward. The 2020 Vision group reported that the intention was to plant some trees opposite the church next spring. Cllr P Smith agreed to follow this up with Bolsover District Council. Regarding the requirement for a new churchyard Cllr A Joesbury contacted Trident Housing whose Chief Executive agreed to meet with members of the Parish Council.
